NOTIFICATION

No. ZU/2758-2855/2023. In exercise of the powers conferred by clause (xvii) of section 2 of the Zakat and Ushr Act, 1985 whereas it extends to the whole of Azad Jammu and Kashmir, and also in the said Act, in Section 3 proclaimed for the compulsory collection of Zakat from all the saving bank accounts maintained in various bank branches situated in Azad Jammu and Kashmir on First day of Ramadan-ul-Mubarik 1443-44 AH., the **amount Rs. 103,159/-** (Rupees: One Hundred Three Thousand One Hundred Fifty-Nine Only) has been fixed as "**Nisab**".

Zakat in respect of assets mentioned in the serial number 1 of the First Schedule, the saving bank account having credit balance equal to **Rs. 103,159/**- (Rupees: One Hundred Three Thousand One Hundred Fifty-Nine Only) or more shall be charged and collected on compulsory basis at the rates and in the manners specified therein, and as may be prescribed from every person and has for the whole of the preceding Zakat year (i.e., entire year) been, "Sahib-e-Nisab" and who owns and possesses such assets on the valuation date.

For all other assets mentioned from serial No. 2 to 11 of the First Schedule of the Zakat and Ushr Act, 1985 all "Deducting Agencies" mentioned in column 5 shall charge and collect Zakat on **"The Deduction Date"** according to the case as mentioned in the Column 4, on compulsory basis at the rates and in manner specified therein.

The collected amount of Zakat shall immediately be transferred to the "Central Zakat Fund Account" maintained in the main branches of relevant banks. The Banks / Financial Institutions or any other Deducting Agency that don't have a Central Zakat Fund Account shall immediately transfer the collected amount of Zakat in the form of Crossed Cheque / Bank Draft / any other form in favor of "Chief Administrator Zakat and Ushr, Muzaffarabad mentioning **A/C 3034282328**, NBP, Main Branch Muzaffarabad, A.K." under official covering letter.

The Deduction Date (First day of Ramadan-ul-Mubarak 1444. A H) likely to fall on 23rd or 24th March 2023 (subject to the appearance of moon) for Saving Bank Accounts at the serial number 1 of the First Schedule shall be deemed to be a public holiday for banks only with in the meanings of the Negotiable Instruments Act, 1881 (XXVI of 1881). Banks shall however, remain open for their employees for assessment and collection of Zakat.

The First Schedule of the Zakat and Ushr Act, 1985 is also included in this notification for all "Deducting Agencies" for reference of specified collection rates and other collection manners:

Note :

- 1. Deduction at source exceeding two and one-half per-cent of the value of an asset specified in this schedule, shall not be made in respect of the asset within the same Zakat year.
- 2. No Zakat shall be charged on the amount paid as premium of a Life Insurance Policy of a person from his provident fund and, where the proceeds of a life insurance policy of a person are credited to his Provident Fund during the Zakat year, Zakat shall be charged on the amount received or drawn during that year as final settlement of his account in the Provident Fund or as non-refundable advance, to the extent of the proceeds so credited.
- 3. If the amount to be deducted at source at Zakat, in a particular case, is less than a rupee, it shall not be charged, and if it is more than a rupee but has a fraction of a rupee, fifty paisas and more shall be treated as the next higher rupee and less than fifty paisas shall not be charged, where the entire amount of the return/balance/settlement of annuity benefits is to be appropriated towards Zakat, and the amount contains a fraction of rupee, this fraction shall not be so appropriated.
- 4. The Deduction Date for serial number 1 shall be deemed to be a public holiday, for banks only, within the meaning of the Negotiable Instruments Act, 1881 (XXVI of 1881) Banks shall, however, remain open for their employees.
- 5. In case the amount of the first return on any of the assets specified at S. Nos. 2, 3 and 5 to 8 or the first instalment of the annuity benefit, is less than the Zakat due, the entire amount of such return or instalment shall be appropriated toward Zakat and the unrealised balance shall be deducted from the subsequent returns or instalments paid during the same Zakat year or, as the case may be, from the encashment or surrender value.
